

#### **Board of Governors Update**

Classified representative to the Board of Governors, Tanna Thomas, provided 4CS with a brief update on recent activities of the BOG.

#### The 2008-2009 CCC System Budget

Request was approved by the BOG and reflects a 12% increase over current funding.

The next meeting of the Board of Governors will be held January 14-15, 2008 in Sacramento.

#### The Community College Initiative

n February 5, 2008 voters will have the opportunity to approve The Community College Governance, Funding Stabilization, and Student Fee Reduction Act. The California Community College Initiative, which:

- Guarantees minimum funding for growth
- Guarantees \$15 per unit fees that can only rise with the cost of living
- Guarantees a system of independent community college districts

Here is the part that you might miss; the language regarding the Board of Governors changes the number of voting seats from 16 to 19 creating twelve public seats, an additional student seat, additional faculty seat and changes the

designated "classified seat". In Section 19 it changes the classified seat as follows:

(d) One Two voting classified current or former employees, who shall be appointed by the Governor for three-year terms a two year term. The Governor shall appoint at least one of the employees the classified employee member from a list of at least three current classified employees persons furnished by the exclusive representatives of classified employees of the California Community Colleges. The Governor shall appoint one of the employees from a list of at least three persons submitted to the Governor by the statewide organization representing community college chief executive officers recognized to participate in the consultation process established by subsection (e) of Section 70901.

This initiative will help ensure that California Community Colleges continue to fulfill their mission of providing affordable education and advancing California's economic growth by continuously improving the state's workforce. #### System Strategic Plan

The System Office began a comprehensive strategic planning process one year ago with the purpose of improving student access and success. On January 17, 2006, the Board of Governors of the California Community Colleges unanimously adopted the final draft of the Strategic Plan.

Developing the Strategic Plan was an unprecedented achievement for the System Office, but the most important and challenging work still lies ahead under the implementation phase of the strategic planning process. Of critical importance are the five Strategic Goal Areas: College Awareness and Access; Student Success and Readiness; Partnerships for Economic and Workforce Development; System Effectiveness; and Resource Development. #### San Diego Mesa College Classified Senate Reaches Out to Local Children

For the past 10 years, the San Diego Mesa College CS has worked with the San Diego Center for Children on their Holiday Bazaar. Throughout the year, we set Koins for Kids jars out in the cafeteria in which the college community can place their spare coins. In past years we have purchased a professional refrigerator, ice maker, and

large cart for the main kitchen and TVs, DVD/VCRs, Playstations and assorted games and movies for the children's game room. Michele West does all of our shopping and with \$500 buys the most amazing gifts that the children can "purchase" at the Bazaar.

The center offers various forms of therapy for the 80 children

and teens, most of whom live at the center 24/7. Many do not see their families and most have behavioral issues steming from their home environment.

The Mesa College Classified Senate is one of more than 100 community organizations that donates money or services to the non-profit center annually. To date, we have donated \$12,000. We provide the children with the tools to learn about sharing and giving to others.

#### The Brown Act Question

The biggest question of 2006-2007? Are Classified Senate's subject to the Ralph M. Brown Act? In short – NO. Unions and 4CS agree that California community college classified senates are not publicly elected bodies, therefore, the Act does not apply. Does the senate have an elected public official as an official voting member of the senate board? To date, we have no record of a senate having such a position. Such a position would require closer scrutiny of the application of the Act, though it is not clear if such a position would still mandate adherence to the Brown Act.

However, it is the organizational opinion of the 4CS that the Brown Act outlines professional rules for open meetings and 4CS recommends that community college classified senates do what they can to follow these guidelines. As classified senates are developed to represent fellow

employees in governance issues, open communication and transparency are essential to encourage trust and inclusion. A classified senate should never operate in a covert manner for any reason and should never portray itself as such. Classified senates have a constitution and/or bylaws that outline how the organization shall meet and confer. It is imperative, to retain credibility, that each senate follow those documents and keep them updated.

Participation in governance in any organization is a responsibility and a commitment to the goals and mission of that organization. It is an opportunity that has been granted by the Legislature for a reason. Such a commitment is serious business and it is essential to operate in a professional manner and respect the process for participation.

Many resources are available on the Brown Act and senate leaders should read and understand the spirit of the document. Mutual respect for those we represent is a foundation for classified senates – being aware of and considering the processes of the Brown Act is a helpful step in that direction.

#### Foundation for California Community Colleges

# Benefiting, Supporting and Enhancing the California Community College System

ince 1998, the Foundation for California Community Colleges (FCCC) has been helping community colleges operate more effectively and efficiently through donations, grants and a diverse array of programs and services. As the sole official auxiliary for the California Community Colleges' Board of Governors, Chancellor and System Office, the Foundation for California Community Colleges is a non-profit organization whose goal is to benefit, support, and enhance the missions of the California Community Colleges System.

FCCC's programs run the gamut from funding programs to grant administration to student employment. FCCC also works with partner organizations to administer nationwide programs such as the Early College High School Initiative, which is committed to improve high school and community college graduation rates, and various AmeriCorps service-learning opportunities. The Facilities Utilization, Space Inventory Options Net, or FUSION, is FCCC's database of California Community College facilities that enables colleges to plan budgets and facilitate the passing of bond measures.

Each year, FCCC passes on millions in grant money to support learning programs on various campuses. Philanthropic support has increased over the years, and last year FCCC contributed more than half a million dollars in direct donations and awards to the Community College System, the System Office and Network of California Community Colleges.

This fall, FCCC welcomed Dr. Paul Lanning as its new President and CEO. Dr. Lanning follows in the steps of FCCC founder, and now President Emeritus, Dr. Larry Toy. With a resume that includes the University of the Pacific, the Community College League of California, and several private sector entrepreneurial ventures, Lanning's extensive experience is proving valuable as FCCC grows and enters its second decade of service.

"I would like to grow the Foundation's public awareness throughout the state. A lot of people know about one or more of our programs, but they may not know or realize the Foundation is behind those programs," said Lanning. "At the same time, we will foster continued growth in the benefits we provide to the colleges. The Foundation provides resources to local colleges and local college

foundations, whose jobs are to raise and manage funds to benefit students and colleges. One of my primary goals is to provide more resources at the local level to those local foundations and our colleges."

The Foundation for California Community College's CollegeBuys Program is a groundbreaking program that has led the way in providing affordable software to community college faculty, students and staff. The innovative program, administered through FCCC since 1999, also offers Faculty/Staff Work-at-Home Rights for faculty and staff members to purchase discounted software for personal computers used for work purposes. In 2003, the Microsoft Student Licensing Program was launched, and gave students the opportunity to purchase fully licensed software at a deep discount; a few years later, the Student Select program was expanded to include community college faculty and staff. FCCC started offering a similar discounted student license program with Adobe in 2006, and in the first year more than 3,600 units were purchased and shipped.

FCCC secures the lowest prices possible by committing to a high minimum number of purchases each year. Coming together to purchase as a system benefits the community college campuses, since it is difficult for some to reach the purchase minimum on their own. Through these agreements, FCCC is able to bring state-of-the-art office and creative software to qualifying faculty, staff and students at prices well below retail.
